# EU Cluster Conference 2024: EACN activities and contributions

The conference gathered nearly 700 participants, including representatives from cluster organisations, policymakers, researchers, entrepreneurs, and a total of 56 speakers around the following main topics

- k the role of clusters in building EU competitiveness
- A pan-European value chains
- ▲ the green and digital transition
- skills, funding and technology

EACN has been identified by the European Commission as a model of cluster collaboration for other industrial ecosystems. Thus, EACN has been invited, for the second time after Prague, to share its insights with the cluster community. # Regensburg's first real laboratory for mobility is launched

Artificial intelligence and digitalisation are set to play a greater role in Regensburg's streetscape in the future. In order to bring corresponding projects from theory into practice, a so-called real laboratory has now been opened at Galgenberg with the "R\_Lab Mobility" project. The project is being funded as part of REGENSBURG\_NEXT and will run until the end of 2026.

The Cluster Mobility & Logistics manages the R\_Lab Galgenberg with the aim to test smart city applications under real conditions together with science and industry. Regensburg is part of Germany's largest smart city funding programme "Model Projects Smart Cities", making it one of 73 "experimental locations" for integrated urban development.

AVL Software and Functions GmbH is launching one of the first application projects: The "Environmental Sensor Box" is intended to lay the foundation for the collection and evaluation of data that can be used for future adaptive mobility concepts.

All data collected in the R\_Lab Mobility will be stored centrally and made available to project participants for research and development purposes. To this end, Stadtwerk.Regensburg is in charge of developing an initial prototype of a data hub for mobility data.

# Mobility and Industry Suppliers Meetings 2024: industry collaboration and innovation in Zaragoza

The 7<sup>th</sup> edition of the Mobility and Industry Suppliers Meetings (MISM), organized on 16 May 2024 by CAAR, and supported by the other Spanish automotive clusters CEAGA, CIAC, FaCyL, AVIA and those from Cantabria, La Rioja, and Navarra, have reached new heights with over 300 attendants, of which 15% came from abroad. Five out of the six major automobile manufacturers in Spain were also present.

#### **CEAGA** presents its new Strategic Plan

More than 140 executives from the Galician automotive and mobility ecosystem participated in the CEAGA Assembly, held last April in Vigo (Galicia).

As part of the event, CEAGA's new strategic plan was presented, the fifth Competitiveness Plan for the Galician Automotive and Mobility Ecosystem (named PCAM 2030). More than 130 companies from the Cluster participated in its preparation with the aim of addressing the needs of the sector over the next four years in key areas such as electrification, mobility, energy and sustainability, among others.

The Assembly also included speeches by the director of Stellantis Vigo, Ignacio Bueno, and the president of CEAGA, Patricia Moreira, who highlighted the great importance of Galician industry and requested support to continue facing the challenges of the future. The event was closed by the President of the Galician Regional Government, Alfonso Rueda, accompanied by the Regional Minister of Economy, Industry and Innovation, María Jesús Lorenzana.

The BRIDGESMEs project, co-funded by the European Commission, launched an open call to select tech-savvy SMEs & start-ups that will benefit from the project's activities and services. The main objective is to foster alliances between tech-savvy SMEs and pilot SMEs (tech adopters) to generate business opportunities and innovative solutions. Applicants must provide solutions for one or more of the BRIDGESMEs targeted five sectors: (1) Mobility, Transport & Automotive; (2) Aerospace & Defence; (3) Electronics; (4) Cultural & Creative Industries; and (5) Tourism. - a concrete action fitting with the future-oriented strategies, values, and objectives of the submitting organisation
- **A** a measurable target.
- A a clear timeframe, ideally with intermediate milestones.

### Corporate sustainability due diligence: Council gives its final approval

The Council has formally adopted the corporate sustainability due diligence directive. The directive introduces obligations for large companies regarding adverse impacts of their activities on human rights and environmental protection; it also lays down the liabilities linked to these obligations. The rules concern not only the companies' operations, but also the activities of their subsidiaries, and those of their business partners along the companies' chain of activities. <u>Further information</u>
